TRANSFER OF FUNDS TO CAPITAL PROJECT #200407
FOR NORTHVIEW GARAGE DEMOLITION COSTS

WHEREAS the low bidder for the Northview Garage Demolition (which is in the scope of Capital Project #200407) withdrew their bid, resulting in the acceptance of the next lowest bona fide bid which causes an increase in project cost, and

WHEREAS the discovery of potential contamination may also increase “clean up” project costs for the Northview Garage Demolition Project, and

WHEREAS these estimated additional expenses require an increase to the capital project appropriations to cover the Northview Garage Demolition, and


WHEREAS the Northview Renovation/Demolition Project #200107 was completed under budget, having funds available to transfer for this purpose.
