

ENROLLED ORDINANCE 164-21

CREATE WORKFORCE DEVELOPMENT  
CENTER COORDINATOR POSITION

WHEREAS the Waukesha County Workforce Development Center was established as a statewide model for the delivery of employment services to both individuals and businesses, and

WHEREAS Waukesha County is one of several partners vested both financially and programmatically in the services provided at the Center, and

WHEREAS it is critical to the overall efficiency and delivery of services that the Center have someone responsible for the coordination of the Center functions and the partner agency programs, and

WHEREAS there is a need to have a stable and competitive employment, wage, and benefit structure in order to attract and maintain a qualified person.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that, effective upon final approval of this ordinance, one regular full-time position of Workforce Development Center Coordinator, 2009 Open Range 12, be created in the Department of Administration.

BE IT FURTHER ORDAINED THAT the Department of Administration General Fund 2009 budget be modified to increase Other Revenue by \$59,500 and increase Personnel Costs by \$59,500 to cover estimated costs related to this position.

BE IT FURTHER ORDAINED that the creation and continuation of this position is subject to the continued funding of direct costs by the Workforce Development Center partner agencies; this position will sunset if the funding is reduced below the direct costs of the position or terminated.


BE IT FURTHER ORDAINED that the classification specification on file in the Department of Administration Human Resources Division and County Clerk's Office is adopted.
