

ENROLLED ORDINANCE 164-30

APPROVE AMENDMENT TO THE 2009 FARM
SERVICE AGENCY RENTAL AGREEMENT

WHEREAS the Farm Service Agency (FSA) currently leases 1,683 square feet of office space in the Waukesha County Administration Center at the annual rate of \$15.56 per square foot and wishes to renew its lease with Waukesha County, and

WHEREAS a rent increase of 4.5% has been proposed and accepted by FSA which will change the rental rate to \$16.26 per square foot, and

WHEREAS the terms of the lease allow annual renewals of the lease but also allows the FSA to terminate with 120 days notice, and

WHEREAS FSA has also requested that the lease termination notice change from the 120 days currently required to 30 days, which is acceptable to the Department of Public Works.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the rental agreement between Waukesha County and the Farm Service Agency shall be renewed for 2009.

BE IT FURTHER ORDAINED that the renewed agreement terms shall include an 4.5% increase in the rent paid over the 2008 rate per square foot, and the termination notice period shall be changed to 30 days.


