

ENROLLED ORDINANCE 164-35

ACCEPT HOMELAND SECURITY-URBAN AREA SECURITY INITIATIVE FY2008
PROGRAM FUNDING AND MODIFY THE EMERGENCY PREPAREDNESS 2009
BUDGET TO APPROPRIATE GRANT REVENUES AND EXPENDITURES TO
PURCHASE COMMUNICATIONS EQUIPMENT FOR THE MOBILE COMMAND POST

WHEREAS, the United States Department of Homeland Security designated Waukesha County, along with the City of Milwaukee, Milwaukee, Ozaukee, Racine and Washington Counties as an Urban Area eligible for grant funding to enhance the capabilities to prevent, respond to, and recover from acts of terrorism and other all hazard events, and

WHEREAS, federal fiscal year 2008 Homeland Security-Urban Area Security Initiative (UASI) grant funding is available to the Urban Area agencies, and

WHEREAS, the Milwaukee UASI included a funding request to purchase communications equipment such as an ACU-1000 for the mobile command post to enhance communication interoperability for emergency response agencies; and

WHEREAS, the United States Department of Homeland Security and the Wisconsin Office of Justice Assistance approved the investment justifications, allocated funding, authorized Waukesha County to submit a grant application, and issued a grant award to fund the purchase of communications equipment for the mobile command post.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Emergency Preparedness Department-Emergency Management Office be authorized to accept \$50,000 of Federal Homeland Security grant funding to fund the purchase of communications equipment for a mobile command post.

BE IT FURTHER ORDAINED that the Emergency Preparedness 2009 budget be modified by increasing Intergovernmental Grant revenues by \$50,000, and increasing Fixed Asset expense appropriations by \$50,000 to pay for equipment purchases related to this grant.
