

ENROLLED ORDINANCE 164-37

RELEASE OF RESERVATION  
PROVIDING ACCESS TO  
WAUKESHA COUNTY LANDS PWT 0923999001

WHEREAS, in November 2002, Randall M. Plautz purchased property identified as PWT 0928977 (Plautz property) in the City of Pewaukee, and

WHEREAS, in December 2003, Waukesha County acquired property identified as PWT 0923999001 (formerly known as the Houghland property), in the City of Pewaukee for the Pewaukee River Greenway, and

WHEREAS, the Plautz property has a right of way reservation stating: “Reserving forever to James A. Houghland and Ella A. Houghland, their heirs and assigns, a right of way one rod (16 ½ ) feet along the south line of said premises and east of the public highway to west line of the Houghland’s land,” and

WHEREAS, as the assign of James and Ella Houghland, Waukesha County now has the reserved right of way over the Plautz property, and

WHEREAS, Randall Plautz wishes to build a garage on the reserved portion of the Plautz property, and


WHEREAS Waukesha County has alternate access to its property, PWT 0923999001, from the north, west and the south and therefore will not be adversely impacted if the right of way reservation is released.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the reservation placed on property PWT 0928977 in the City of Pewaukee shall be released.

BE IT FURTHER ORDAINED that the Corporation Counsel and the Director of the Department of Parks and Land Use shall review or prepare the documents necessary to release the reservation, and the Director of the Department of Parks and Land Use is further authorized to execute said documents on behalf of the County with the Waukesha County Register of Deeds.




