ACCEPT AMERICAN RECOVERY AND REINVESTMENT ACT OF 2009 EQUIPMENT ASSISTANCE GRANT FUNDS FOR SCHOOL FOOD AUTHORITIES AND MODIFY THE WAUKESHA COUNTY DEPARTMENT OF HEALTH AND HUMAN SERVICES 2009 BUDGET TO APPROPRIATE GRANT EXPENDITURES AND REVENUES FOR A REPLACEMENT OVEN IN THE JUVENILE CENTER

WHEREAS the American Recovery and Reinvestment Act of 2009-Equipment Assistance Grants for School Food Authorities appropriated funding for the purchase of equipment for public schools, and

WHEREAS the grant will be disbursed through the State of Wisconsin Department of Public Instruction through September 23, 2009, and

WHEREAS Waukesha County is Eligible to receive an allocation of this grant funding of \$2,228, and

WHEREAS the Waukesha County Department of Health and Human Services (Juvenile Center) will use the funds to purchase a replacement oven for the Juvenile Center.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Department of Health and Human Services (Juvenile Center) is authorized to accept \$2,228 of American Recovery and Reinvestment Act of 2009-Equipment Assistance Grants for School Food Authorities funding to replace an oven in the Juvenile Center.


