

ENROLLED ORDINANCE 165-29

RATIFICATION OF PROCLAMATION OF EMERGENCY FOR WEATHER
RELATED INCIDENT IN WAUKESHA COUNTY ON JUNE 21, 2010

WHEREAS, severe weather struck Waukesha County on the evening of June 21, 2010, including an F2 tornado in Eagle and an F1 tornado in Big Bend and Muskego, and

WHEREAS, the National Weather Service issued a disaster declaration for Waukesha County, and

WHEREAS, several locations in Waukesha County sustained severe storm damage and as a result the County was required to mobilize numerous resources to respond to that damage, and

WHEREAS, the severe weather caused injuries to persons and structural damage to buildings, including residences, and


WHEREAS, the County Executive, pursuant to the power provided to him and the County Board in Wisconsin Statute 323.11, issued an official proclamation declaring an emergency on June 22, 2010, and


WHEREAS, Wisconsin Statute 323.14(3) requires the ratification of the County Executive's proclamation by the Waukesha County Board.


