WHEREAS, this equipment is a portable hard drive that will allow detectives to image computers outside the computer forensics office, and

WHEREAS, Waukesha County Code Section 7.91(b)4 requires that in kind donations with a replacement value of two thousand dollars (\$2,000) or more as determined by the recipient department or those subject to a special condition must be accepted by the County Board, and

WHEREAS, the estimated value for the computer equipment donation is \$2,674, and


WHEREAS, this equipment will not be included in a replacement plan or replacement will not be levy funded.



FISCAL NOTE

**ACCEPT DONATED COMPUTER FORENSICS EQUIPMENT FROM THE GREATER
MILWAUKEE FOUNDATION**

This ordinance authorizes the Waukesha County Sheriff's department to accept the donation of a portable hard drive and associated software valued at \$2,674 from the Greater Milwaukee Foundation. The equipment will be used to make images of computers without the need to transport them to the computer forensics office.

According to the Department, this item will not be included in the Sheriff's replacement plan or replaced with tax levy funds. Any required maintenance costs are expected to be minimal and will be absorbed within the Sheriff Department's existing budget.
