

ENROLLED ORDINANCE 166-24

REPEAL AND RECREATE SECTION 7-91(a) 2B OF THE WAUKESHA COUNTY  
CODE OF ORDINANCES TO CHANGE REQUIRED VOTE TOTAL TO  
ACCEPT AND APPROPRIATE DONATED FUNDS

WHEREAS, Section 7-91(a)2 B of the Waukesha County Code of Ordinances was enacted when the County Board consisted of 35 members, and designates that a vote of 24 members, or two-thirds of the membership, was required to enact an ordinance to accept and appropriate donated funds, and

WHEREAS, the size of the County Board was reduced to 25 members by Enrolled Ordinance 161-77, and

WHEREAS, as a two-thirds vote now requires only 17 votes, Section 7-91(a) 2 B should be amended, and

WHEREAS, rather than specifying a number of votes, it is a better practice to express the requirement as a percentage of the Board membership.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that:

SECTION 1. Section 7-91(a) 2 B of the Waukesha County Code is repealed and recreated to read:

Ordinance appropriation. A donation received in a particular year can be proposed for use in the same year through the normal ordinance process. The amount and purpose must be specified in the ordinance for acceptance and appropriation by the county board. This type of an appropriation is considered a budget amendment and requires affirmative votes by two-thirds of the membership of the county board.


SECTION 2. This ordinance shall be effective upon approval and publication.


SECTION 3. The provisions of this ordinance shall be included and incorporated in the Code of Ordinances of the County of Waukesha, Wisconsin, as an addition or amendment thereto and shall be appropriately renumbered to conform to the numbering system contained therein.


SECTION 4. Any code section or part of a section in conflict with this ordinance is hereby repealed and declared null and void and of no effect.
