ACCEPT DONATED PONTOON BOAT FROM SKIPPER BUDS

WHEREAS, Skipper Buds would like to donate a 1987 pontoon boat and out board motor to the Sheriff's Department for use with the Cops and Bobbers program and the Waukesha County Sheriff's Dive Team, and

WHEREAS, the boat is in fair condition and has a 2001 outboard motor that is reportedly in good working order, and

WHEREAS, the Sheriff's Department currently uses rental equipment for the Cops and Bobbers program and has utilized privately owned boats for various dive team operations, and

WHEREAS, Waukesha County Code Section 7.91(b)4 requires that in kind donations with a replacement value of two thousand dollars (\$2,000) or more as determined by the recipient department or those subject to a special condition must be accepted by the County Board, and

WHEREAS, the estimated value of the pontoon boat and outboard motor is \$3,575, and


WHEREAS, this boat and motor will not be included in a replacement plan nor will replacement be levy funded.



FISCAL NOTE

ACCEPT DONATED PONTOON BOAT FROM SKIPPER BUDS

This ordinance authorizes the Waukesha County Sheriff's Department to accept the donation of a pontoon boat and outboard motor with an estimated value of about \$3,575. According to the Department, annual operating costs are estimated at less than \$1,000, and will be absorbed within the existing operating budget. The boat will not be added to the Vehicle and Equipment Replacement Fund.
