ACCEPT JOINT FEDERAL JUSTICE ASSISTANCE GRANT AND  
MODIFY WAUKESHA COUNTY SHERIFF DEPARTMENT'S 2011  
BUDGET TO AUTHORIZE GRANT EXPENDITURES

WHEREAS, the federal Edward Byrne Justice Assistance Grant program (JAG) has made grant funds available to the Waukesha County Sheriff's Department in partnership with the City of Waukesha Police Department, and

WHEREAS, these grant funds became available after the 2011 budget process was completed, and

WHEREAS, the Sheriff's Department will use this funding for additional safety equipment to enhance law enforcement operations.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Sheriff's Department accept \$5,000 of federal Edward Byrne Justice Assistance Grant funding.




ACCEPT JOINT FEDERAL JUSTICE ASSISTANCE GRANT AND  
MODIFY WAUKESHA COUNTY SHERIFF DEPARTMENT'S 2011  
BUDGET TO AUTHORIZE GRANT EXPENDITURES

This ordinance authorizes the Sheriff's Department to appropriate \$5,000 of Edward Byrne Justice Assistance grant award funds in partnership with the City of Waukesha Police Department to the 2011 Budget for the Sheriff. The City will act as the fiscal agent and will provide the funds as a condition of receiving a City of Waukesha grant award. These federal funds will be used for additional safety equipment to enhance law enforcement operations. No County indirect costs are covered by this grant funding.

The Department's cost estimates related to this ordinance are as follows:

(7) Gas Masks for the Jail	\$1,000
(13) CBRN (chemical, biological, radiological, and nuclear) masks for Patrol	\$4,000
