ESTABLISH TENTATIVE COUNTY SUPERVISORY DISTRICT PLAN


WHEREAS Wisconsin Statute 59.10(3)(b) requires county boards to propose a tentative county supervisory district plan which sets forth the number of supervisory districts and tentative boundaries within 60 days after receipt of the federal decennial census count by block, and

WHEREAS the block count was received on March 29, 2011, and


WHEREAS after a public hearing and the giving of requisite notice of said hearing, the Waukesha County Board Executive Committee reviewed a draft tentative county supervisory district plan at its April 18, 2011 meeting, and

WHEREAS the Executive Committee recommends to the Waukesha County Board of Supervisors a tentative supervisory district plan with 25 districts and boundaries as set forth in the district map made part of this resolution.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA
RESOLVES that the tentative supervisory district plan for Waukesha County, prepared in accordance with Section 59.10(3)(b), Wis. Stats., shall be established as set forth in the attached supervisory district plan map, a full size copy of which is on file and available for viewing in the offices of the Waukesha County Board and the Waukesha County Clerk.

Waukesha County 2011 Proposed Supervisory Districts


