

ENROLLED RESOLUTION 167-6

APPROVE WEST WAUKESHA BYPASS

WHEREAS, the completion of the Waukesha Bypass has been planned for fifty years and the western portion of the bypass, commonly known as the West Waukesha Bypass, is the final element yet to be constructed, and

WHEREAS, Waukesha County, the City of Waukesha, the Town of Waukesha and the Wisconsin Department of Transportation have signed a Memorandum of Understanding to complete the construction of the West Waukesha Bypass, and

WHEREAS, the terms of the Memorandum of Understanding commit Waukesha County to be the lead agency for the project, and

WHEREAS, Waukesha County in cooperation with the Wisconsin Department of Transportation, City of Waukesha and Town of Waukesha has conducted an Environmental Impact Statement (EIS) for the project, and

WHEREAS, the EIS study has enumerated various alignments for the West Waukesha Bypass route and has reduced the number of alternates to four: the no build alternate and three build alternates, these are the alternates referred to as Pebble Creek West, Pebble Creek far West and the alternate referred to as CTH X and Sunset Drive, and

WHEREAS, the results of further study of those alternates has shown that, based on factors such as environmental impacts, ground water impact, safety, cost and traffic efficiency, the alternate referred to as Pebble Creek West is the preferred alignment for the West Waukesha Bypass.


IT IS HEREBY RESOLVED THAT the County Board of Supervisors of the County of Waukesha supports the construction of the West Waukesha Bypass.

BE IT FURTHER RESOLVED THAT the County Board of Supervisors of the County of Waukesha recommends to the Wisconsin Department of Transportation and the Federal Highway Administration the alternate known as Pebble Creek West for the selected alignment of the West Waukesha Bypass.


