ACCEPT TWO DONATED TRUNK VAULTS FOR THE WAUKESHA  
COUNTY SHERIFF'S DEPARTMENT, CANINE UNIT

WHEREAS, Stan Kass expressed an interest in donating to the Waukesha County Sheriff's Department two new trunk vaults for the canine unit with a total value of \$5,000, and

WHEREAS, the trunk vaults would provide the two canine cars that are being replaced in 2014 with secure and organized storage for canine training equipment, and

WHEREAS, Waukesha County Code Section 7.91(b)4 requires that in-kind donations with a replacement value of two thousand dollars (\$2,000) or more as determined by the recipient department or those subject to a special condition must be accepted by the County Board, and


WHEREAS, the value of the trunk vaults is approximately \$5,000, and


WHEREAS, these trunk vaults will not be included in a replacement plan or replacement will not be levy funded.


