## Prescription Drug Take Back – Waukesha County

On April 22<sup>nd</sup>, 2023, the Wisconsin Department of Justice (DOJ) coordinated a Prescription Drug Take Back Initiative throughout Wisconsin. Drug Take Back events provide a safe and convenient method for our communities to dispose of unwanted and/or unused medication. They also serve as a mechanism to educate the community about the potential abuse and consequences of improper storage and disposal of prescription medications.

The Wisconsin initiative was part of the Drug Enforcement Administration's - National Drug Take Back day. Wisconsin Department of Justice recently announced that Wisconsin collected an approximate total of 55,472 lbs during the spring 2023 event. Waukesha County accounted for approximately 6035 lbs. of the Wisconsin total.

The Waukesha County Sheriff's Office teamed up with the Wisconsin Department of Justice, as well as the Cities of Waukesha, Delafield, Muskego, New Berlin, Pewaukee, and Oconomowoc, Villages of Butler, Eagle, Menomonee Falls, Mukwonago, Pewaukee, Sussex, North Prairie, Elm Grove, and Lannon, and Town of Brookfield to manage event day collection sites around Waukesha County.

Many of these communities, as well as several others not listed, are also supported by permanent drug disposal boxes in their local police departments. The drug take back events provide an opportunity for law enforcement agencies to safely dispose of accumulated, unwanted, and unused prescription drugs collected in these permanent disposal boxes.
