

ENROLLED ORDINANCE 179-62

AUTHORIZE THE WAUKESHA COUNTY SHERIFF'S DEPARTMENT TO AMEND THE MUNICIPAL PATROL SERVICES CONTRACTS WITH THE VILLAGES OF SUSSEX, LISBON, AND MERTON TO CHANGE THE COST SHARING FOR THE CONTRACTED LIEUTENANT POSITION BEGINNING JANUARY 1, 2025

WHEREAS, the Village of Sussex, the Village of Lisbon, and the Village of Merton all have contracts for police patrol services with Waukesha County; and

WHEREAS, the term of the current police patrol services contract with the Village of Sussex is from January 1, 2024 through December 31, 2028; and

WHEREAS, the term of the current police patrol services contract with the Village of Lisbon is from January 1, 2023 through December 31, 2027; and

WHEREAS, the term of the current police patrol services contract with the Village of Merton is from January 1, 2024 through December 31, 2028; and

WHEREAS, all three of these communities have agreed to a cost sharing agreement for supervisory services that are currently paid for by the Village of Sussex through their contract with the County; and

WHEREAS, the proposed changes do not have a financial impact on the 2025 Sheriff's Department budget; and

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the three contract amendments on file with the Waukesha County Sheriff's Department to modify the allocation of a contract lieutenant working in the Village of Sussex, Village of Lisbon and Village of Merton beginning January 1, 2025, is hereby approved and the Waukesha County Sheriff is authorized to execute the contract amendments.
