MODIFY THE 2016 BUDGET OF THE DEPARTMENT OF HEALTH AND HUMAN SERVICES TO APPROPRIATE EXPENDITURES FOR CLINICAL SERVICES AND INCREASE OTHER REVENUE

WHEREAS, the Health and Human Services Clinical Division provides community based services for Medicaid eligible clients, and

WHEREAS, Waukesha County receives revenue reimbursement for community services as a Medicaid provider, and

WHEREAS, the Waukesha County Department of Health and Human Services as a Medicaid provider of community-based services is required to submit an annual cost report to the Wisconsin Medicaid Program, and

WHEREAS, the Wisconsin Medicaid Cost Reporting (WIMCR) is a cost-based payment system for counties enrolled as Medicaid providers of community-based services that provides additional funding to counties, and

WHEREAS, based on the Waukesha County's most recently settled WIMCR cost report, revenue estimates are projected to exceed budget by \$160,000 due to the cost allocation methodology employed by the State, and

WHEREAS, expenditures for community-based mental health outpatient services provided by the Health and Human Services Department are anticipated to be over budget in 2016.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Department of Health and Human Services 2016 Budget be modified by appropriating operating expenditures of \$160,000 for community-based mental health outpatient services and increasing Other Revenues by \$160,000 for the prior year revenue reimbursement.

This ordinance modifies the 2016 Waukesha County Department of Health and Human Services-budget by increasing expenditures by \$160,000 in the Clinical Services division to fund operating expenses related to community-based mental health outpatient services provided throughout the county. The ordinance increases other revenues by \$160,000 for higher than budgeted reimbursements for providing mental health outpatient Medicaid services, based on the most recently settled Wisconsin Medicaid Cost Reporting (WIMCR) review.
