# Children with Special Needs Long Term Support Waiver Program

## What is the Children's Long Term Support Waiver Program?

The Children's Long Term Support (CLTS) Waiver Program helps children and youth under the age of 22 through supports and services live at home and participate in their communities. The CLTS Waiver Program supports children and youth who have substantial limitations in multiple daily activities of living as a result of one or more of the following disabilities:

- Intellectual and/or developmental disabilities
- Physical disabilities
- Mental health disabilities

To apply for the CLTS Waiver Program please contact the Children's Intake Line at (262) 896-3397. A functional screen is completed in the home with the child, or youth, and family to determine eligibility.

A child or youth in the CLTS Waiver Program works with a Support and Service Coordinator (SSC) to find services they need and develop an Individualized Service Plan (ISP). The ISP will include the services and supports that are needed to address the child, or youth and family's unique needs.

The CLTS Waiver Program covers a broad range of services depending on the identified needs for the child or youth and family. These services are listed in the child or youth's ISP along with identified outcomes. Outcomes are statements about what is important to the family. The SSC makes a referral and authorization to available providers for the identified service needs of the child or youth and family.

- Assistive technology
- Child care services
- Communication assistance
- Community integration services
- Counseling and therapeutic services
- Daily living skills training
- Discovery and career planning
- Empowerment supports
- Financial management services
- Grief and bereavement services
- Health and wellness
- Home modification
- Mentoring
- Personal emergency response
- Personal supports
- Respite
- Safety planning and prevention
- Specialized medical and therapeutic supplies
- Transportation
- Vehicle modifications

**In order to participate in this program, a source of Medicaid is needed. If your child qualifies, we will help establish a Medicaid source as part of the enrollment process.**
