WHEREAS, donations were not anticipated nor included in the 2022 budget.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County UW Extension Department be authorized to accept the donations specified in this ordinance in the total amount of \$12,527 for 4-H and Juvenile Community Garden activities.

BE IT FURTHER ORDAINED that the Waukesha County UW-Extension Department's 2022 budget be modified by increasing the department's operating expenditure appropriation unit by \$12,527and other revenues by \$12,527.
