

ENROLLED ORDINANCE 177-78

AUTHORIZE THE WAUKESHA COUNTY DEPARTMENT OF ADMINISTRATION TO ACCEPT UNITED STATES DEPARTMENT OF TREASURY AMERICAN RESCUE PLAN ACT – LOCAL ASSISTANCE AND TRIBAL CONSISTENCY FUND GRANT FUNDING

WHEREAS, in March 2021, the federal government approved legislation authorizing and funding the American Rescue Plan Act (ARPA), which authorized the United States Department of Treasury to provide \$2.0 billion across fiscal years 2022 and 2023 to eligible local governments for use on any governmental purpose except for lobbying activities; and

WHEREAS, this is a separate allocation from the \$78.5 million that the County received in Coronavirus State and Local Fiscal Recovery Funds (CSLFRF); and

WHEREAS, Waukesha County's allocation is \$100,000, with \$50,000 available in 2022 and \$50,000 available in 2023; and

WHEREAS, the cost of ballots for elections has nearly doubled during 2022 from \$0.11 to \$0.21 per ballot; and

WHEREAS, the finance committee previously approved a Contingency Fund transfer of \$70,000 to the County Clerk's Office, mostly related to higher ballot costs; and

WHEREAS, this funding is available to partially offset the need to utilize Contingency Funds for higher ballot costs in 2022.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS the Waukesha County Department of Administration is authorized to accept US Department of Treasury American Rescue Plan Act Grant funding through the Local Assistance and Tribal Consistency Fund program to fund permissible expenditures.

BE IT FURTHER ORDAINED that the Waukesha County Clerk's 2022 budget be modified to increase general government revenues by \$50,000 and decrease fund balance use from the Contingency Fund by \$50,000.
