

ENROLLED ORDINANCE 170-86

LAYING OUT, RELOCATION AND IMPROVEMENT OF COUNTY TRUNK
HIGHWAY NN, WAUKESHA COUNTY PROJECT I.D. 14-2819(4)A

WHEREAS, the County Board of Supervisors of Waukesha County finds that the proper improvement in maintenance of County Trunk Highway NN in the Village of Mukwonago from a point that is 1,337.60 feet west of and 614.25 feet North of the South One-Quarter corner of Section 24, Town 5 North, Range 18 East, Village of Mukwonago, Waukesha County, State of Wisconsin, to a point that is 179.62 feet North of and 60.12 feet West of the South One-Quarter Corner of Section 24, Town 5 North, Range 18 East, Village of Mukwonago, Waukesha County, State of Wisconsin requires certain relocation or changes and the acquisition of certain rights of way as shown on the plat marked "Plat of Right of Way Required for CTH NN Project ID 14-2819(4)A, STH 83 to CTH ES POND."


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA DOES ORDAIN that the plat marked "Plat of Right of Way Required for CTH NN Project ID 14-2819(4)A, STH 83 to CTH ES POND" on file in the County Clerk's office is adopted by reference under the authority granted by Section 83.08 and Chapter 32 of the Wisconsin Statutes.

IT IS FURTHER ORDAINED that County Trunk Highway NN in the Village of Mukwonago is hereby changed or relocated from a point that is 1,337.60 feet west of and 614.25 feet North of the South One-Quarter corner of Section 24, Town 5 North, Range 18 East, Village of Mukwonago, Waukesha County, State of Wisconsin, to a point that is 179.62 feet North of and 60.12 feet West of the South One-Quarter Corner of Section 24, Town 5 North, Range 18 East, Village of Mukwonago, Waukesha County, State of Wisconsin, accordance with the "Plat of Right of Way Required for CTH NN Project ID 14-2819(4)A, STH 83 to CTH ES, POND."

IT IS FURTHER ORDAINED that the County shall acquire those rights of way and other interests as shown on the "Plat of Right of Way Required for CTH NN Project ID 14-2819(4)A, STH 83 to CTH ES, POND."






