WHEREAS, the Mental Health Center has experienced an increased need for medical beds in place of standard non-adjustable hospital beds to meet client needs with serious medical conditions such as seizure disorders and fall risks; and

WHEREAS, Froedtert Menomonee Falls Hospital offered to donate four (4) medical beds previously used in their behavioral health unit that closed in May 2023; and

WHEREAS, the value of the medical beds are \$5,185 per bed for a total value of \$20,740; and,

WHEREAS, there are no conditions attached to the acceptance of the in-kind donation; and,

WHEREAS, Waukesha County Code Sec. 7-91(b)4. requires in-kind donations with a replacement value of five thousand dollars (\$5,000) or more, as determined by the recipient department, or those subject to a special condition, must be accepted by the County Board.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Department of Health and Human Services is authorized to accept the in-kind donation of four (4) medical beds from Froedtert Menomonee Falls Hospital.
