

ENROLLED ORDINANCE 176-86

CREATE A PARKING REGULATION FOR CTH E
IN THE VILLAGE OF NORTH PRAIRIE

WHEREAS the Office of the Commissioner of Railroads (OCR) has ordered the Wisconsin and Southern Railroad to install and maintain 12-inch LED mast mounted automatic flashing lights with gates, an electronic bell, constant warning time circuitry, and other appropriate appurtenances at the crossing of its tracks with CTH E in the Village of North Prairie; and

WHEREAS in the process of designing the crossing improvements, it was determined that the existing parking lanes on CTH E posed sight line obstruction issues affecting the safety and function of the crossing; and

WHEREAS the creation of a prohibited parking area at this location provides safe visibility of traffic conditions for motorists; and

WHEREAS Section 349.13 of the Wisconsin Statutes provides that local authorities may regulate the parking, standing and stopping of vehicles along highways.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS the following parking regulation shall be in effect upon placement of proper signs therefore:

Both sides of CTH E from a point 110 feet South of the centerline of Sadd Street southerly to a point that is 260 feet south of the centerline of Sadd Street in the Village of North Prairie – No Parking at Any Time.


BE IT FURTHER ORDAINED that this ordinance rescinds all other previous parking restrictions for the above-described portion of County Trunk Highway E in the Village of North Prairie.



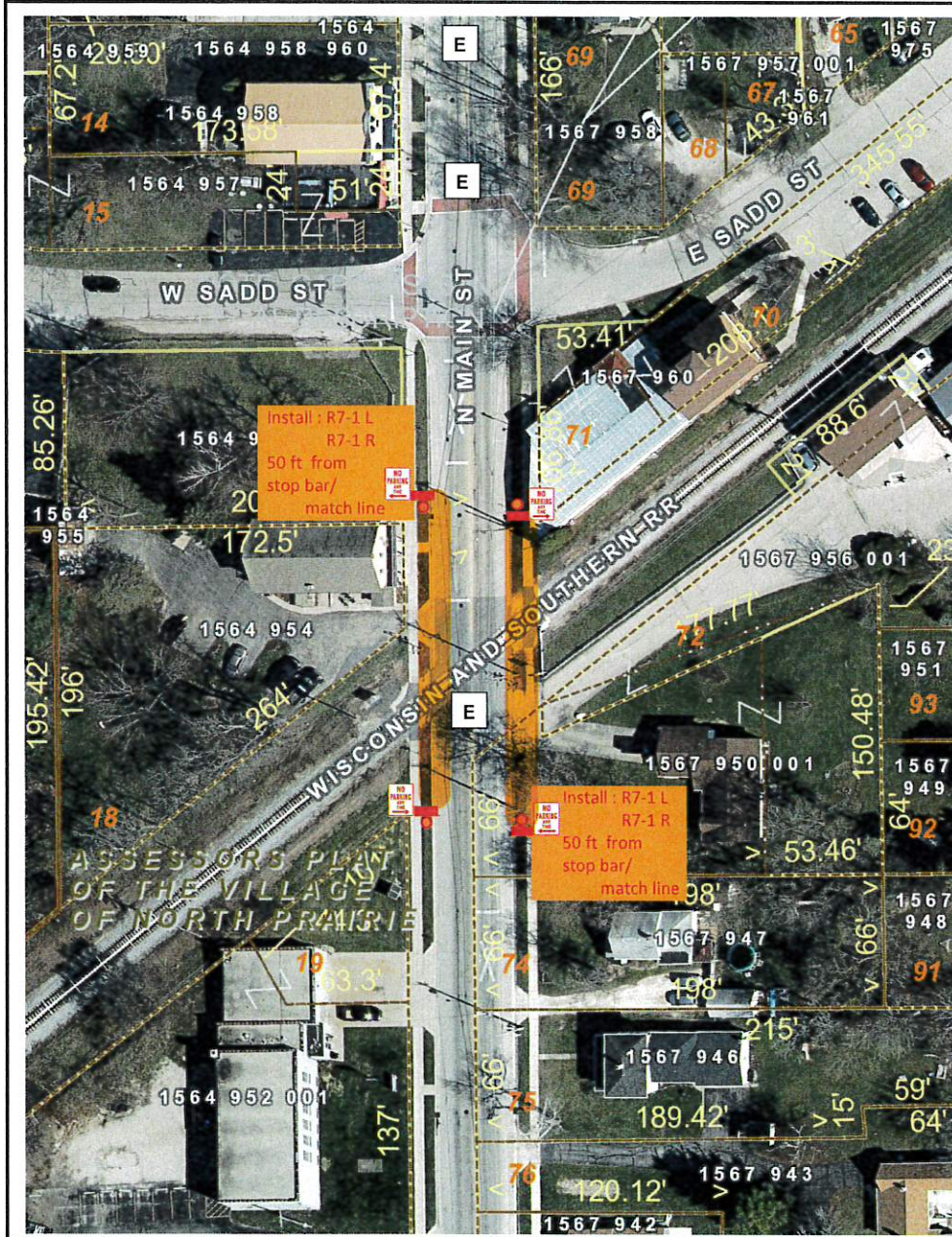
