FISCAL NOTE

CANCEL UNREDEEMED CHECKS ISSUED BY COUNTY TREASURER IN 2010

Upon approval of this ordinance, un-cashed checks on the list referenced by the ordinance will be cancelled and funds totaling \$9,203.72 will be placed in a liability account of the Unclaimed Property Fund. Pursuant to Wisconsin Statute 59.64(4)(e), any individual or entity in whose favor those checks were drawn shall have six years from the date of passage to have the check re-issued without interest. The funds for any new check issued and cashed will be drawn from the liability account. Whatever funds remain unclaimed after six years will be transferred to an appropriate revenue account of the General Fund. During the six year period of time, the funds will be invested and the investment income earned will be allocated to the General Fund.

This ordinance requires no additional tax levy.
