APPROVE COMPROMISE SETTLEMENT FOR WORKER'S COMPENSATION

WHEREAS an employee of the Waukesha County Sheriff's Department has filed a Worker's Compensation claim against Waukesha County for injuries allegedly occurring while employed with Waukesha County; and

WHEREAS the continuation of the litigation possesses substantial risk to both sides of the litigation and both sides will continue to incur significant additional expenses without a settlement; and

WHEREAS the employee has expressed a willingness to enter into a settlement agreement which is on file in the Corporation Counsel's office pending approval by the County Board and which has been shared in closed session with the County Board; and

WHEREAS it has been determined that settlement of these issues at this time is in the best interest of Waukesha County.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the settlement agreement on file with the Corporation Counsel and previously shared with the Board in the Worker's Compensation case entitled Bryan Bindel vs. County of Waukesha is hereby approved.
