BE IT FURTHER ORDAINED that the agreement between the Estate of Dolores M. Passamani and Waukesha County to complete the transfer is hereby approved.

BE IT FURTHER ORDAINED that the Waukesha County Department of Parks and Land Use is authorized on behalf of Waukesha County to complete land transfer expenses with funds from the Walter J. Tarmann Parkland Acquisition Fund.

BE IT FURTHER ORDAINED, that the Waukesha County Clerk and Waukesha County Executive are authorized to execute all necessary applications and agreements in order to secure potential state and federal funds for said property.

LAND DONATION AGREEMENT ESTATE OF DOLORES M. PASSAMANI AND WAUKESHA COUNTY

This Agreement between Waukesha County (hereinafter "County"), and the Estate of Dolores M. Passamani (hereinafter "Passamani Estate") reflects each party's understanding as to the donation of two (2) acres of vacant land located within part of the SW ¼ of Section 23, T5N, R19E, in the Town of Vernon, Waukesha County, Wisconsin more particularly described on Exhibit "A" which is attached hereto and incorporated herein by reference (hereinafter "Property").

WHEREAS, the Passamani Estate wishes to donate the Property to the County; and

WHEREAS, the County wishes to accept donation of the Property which will become part of the Fox River Greenway subject to acceptance by the Waukesha County Board.

NOW, THEREFORE, the County and Passamani Estate mutually agree to the following provisions to effectuate the above intention:

- 1. County and Passamani Estate agree that the value of the Property is Fifteen Thousand and 00/100 Dollars (\$15,000.00) based upon the 2015 tax assessment.
- 2. Passamani Estate shall be responsible for the payment of the real estate taxes on the Property from January 1, 2016 through the day the Waukesha County Board accepts the donation. County shall be responsible for the payment of the real estate taxes on the Property from the day after the Waukesha County Board accepts the donation through December 31, 2016.
- 3. County shall pay for an owner's policy of title insurance issued by Land Title Services, Inc. (Commitment No. 16402257W).
- 4. Passamani Estate shall transfer ownership of the Property to County by Warranty Deed and a Wisconsin Real Estate Transfer Return.
- 5. County's acceptance of the donation is subject to Waukesha County Board approval.
