TERMINATION OF STATE OF EMERGENCY REGARDING COVID-19

WHEREAS, on March 13, 2020 the Waukesha County Executive, by proclamation pursuant to authority under Sections 323.11 and 323.14(4)(b), Wisconsin Statutes, declared a state of emergency in Waukesha County in light of the public health threat posed by COVID-19 for a period of sixty-days in order to facilitate and expedite the use of resources to protect persons from the impacts of the spread of COVID-19 while ensuring continuity of critical operations within Waukesha County, and

WHEREAS, the WaukeshA County Board of Supervisors adopted Enrolled Resolution 174-3, Ratifying and Further Modifying Emergency Declaration Regarding COVID-19 at its meeting March 24, 2020, and

WHEREAS, Enrolled Resolution 174- 3 provided for the state of emergency to remain in effect during the time emergency conditions existed or were likely to exist, and

WHEREAS, the declared state of emergency provided flexibility to effectively engage emergency operations to mitigate the virus within Waukesha County, and

WHEREAS, throughout the past year, Waukesha County focused on enhancing capabilities to control the COVID-19 pandemic in areas including: contact tracing and disease investigation, testing, data collection/visualization, intergovernmental partnerships and vaccination, and

WHEREAS, the public health situation has improved and stabilized as represented by low infection and hospitalization rates and vaccination rates above 50% and increasing, and

WHEREAS, the county, its residents, and its businesses will benefit from a return to prepandemic normalcy.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA RESOLVES that the state of emergency ratified and modified through Enrolled Resolution 174-3, is hereby terminated, effective upon adoption of this resolution.
