

ENROLLED ORDINANCE 168-39

AUTHORIZE THE WAUKESHA COUNTY UNIVERSITY OF WISCONSIN
COOPERATIVE EXTENSION OFFICE TO ACCEPT GRANT FUNDS FOR
THE SOBER TRUTH ON PREVENTING UNDERAGE DRINKING (STOP)
PROGRAM AND MODIFY THE 2013 BUDGET ACCORDINGLY

WHEREAS, the U.S. Department of Health and Human Services – Substance Abuse and Mental Health Services Administration has awarded grant funds in the amount of \$9,625 to the Waukesha County University of Wisconsin Cooperative Extension to extend prevention of underage alcohol use to more school districts, and

WHEREAS, this award is intended to focus on preventing and reducing alcohol use among youth in Waukesha County communities, specifically among youth ages 12 to 20, and

WHEREAS, the grant seeks to strengthen collaboration between Waukesha County Drug Free Communities Coalition and school districts who have signed Memorandums of Understanding knowing what resources and commitments they will need to deliver to make this project successful and valuable in communities, and

WHEREAS, the program aligns with the Substance Abuse and Mental Health Services Administration’s strategic initiative to prevent substance abuse. In addition, the long-term benefit is implementation of an evidence based, environmental strategies model focused on alcohol use prevention and reduction among youth along with a federally required evaluation of the program, and

WHEREAS, the 2013 adopted budget did not include revenues or expenditure authority for this additional \$9,625.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County University of Wisconsin Cooperative Extension is authorized to accept grant funds in the amount of \$9,625 from the Department of Health and Human Services – Substance Abuse and Mental Health Services Administration for the STOP program.

BE IT FURTHER ORDAINED that the Waukesha County University of Wisconsin Cooperative Extension Office’s 2013 budget be modified to increase General Government Revenues by \$9,625 and increase Operating Expense appropriations by \$9,625 to cover costs associated with this grant-funded, STOP program.

This ordinance authorizes the Waukesha County University of Wisconsin Cooperative Extension Office to accept \$9,625 in U.S. Department of Health and Human Services – Substance Abuse and Mental Health Services Administration funds. The funding will be used to for a program aimed at working with school districts to prevent and reduce underage alcohol use. The ordinance authorizes the modification of the 2013 University of Wisconsin Cooperative Extension budget by appropriating an additional \$9,625 in contracted services and operating expenditures and increasing program grant revenue by \$9,625.

This ordinance has no direct impact on 2013 tax levy.
