WHEREAS, the currently in-place drainage facility (culvert) serves to remove storm water from a portion of the I-94 Highway east of Waukesha County Highway "P," and

WHEREAS, a permanent limited easement provides the Wisconsin Department of Transportation the right to construct, improve and maintain the existing drainage facility including the right to operate the necessary equipment thereon and the right to ingress and egress as long as required for a public purpose, and

WHEREAS, in consideration for the Permanent Limited Easement, Wisconsin Department of Transportation will pay Waukesha County \$2,600.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Permanent Limited Easement between State of Wisconsin Department of Transportation and Waukesha County, which permits construction and maintenance to an existing drainage facility, located in Section 24, Township 7 North, and Range 17 East to be recorded with the Register of Deeds, is hereby approved.

BE IT FURTHER ORDAINED that the Director of Waukesha County Department of Parks and Land Use may execute all documents for the Permanent Limited Easement on behalf of Waukesha County.

BE IT FURTHER ORDAINED that revenue of \$2,600 from this Permanent Limited Easement be deposited into the Walter J. Tarmann Parkland Maintenance Fund.








PERMANENT LIMITED EASEMENT TO WIDOT
