

ENROLLED ORDINANCE 168-87

DIRECT THE WAUKESHA COUNTY CLERK'S OFFICE TO INVITE PROPOSALS FROM  
NEWSPAPERS PUBLISHED IN WAUKESHA COUNTY TO ACT AS THE  
OFFICIAL NEWSPAPER FOR WAUKESHA COUNTY

WHEREAS, Wisconsin Statute 985.065(2)(a) pertaining to counties having a population of 250,000 or more, states the county board of supervisors shall direct the county clerk to invite proposals from the English newspapers published daily in said county, for all notices or advertisements as shall be authorized or required by said board and all officers, boards and departments of Waukesha county during the next ensuing year, and

WHEREAS, Wisconsin Statute 985.065(2)(f) permits said board of supervisors, in lieu of the foregoing provisions, to provide by ordinance a method of printing and publishing and the method of obtaining bids and contracts therefore, and

WHEREAS, the County Board through its annual budget process has appropriated funds for the use of an official newspaper in a number of different county department budgets.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Clerk shall invite proposals from the English newspapers published in Waukesha County to act as the official newspaper to publish all notices or advertisements as shall be authorized or required by said board and all officers, boards and departments of Waukesha County.

BE IT FURTHER ORDAINED that the County Clerk will work with the Department of Administration in preparing and issuing this invitation.


BE IT FURTHER ORDAINED that pursuant to Wis. Stat. 985.065(2)(f), the proposal shall provide for a contract of not less than 2 years subject to the approval of the Executive Committee and the County Clerk with an option to extend for additional periods subject to the approval of the Executive Committee and the County Clerk.
