## MODIFY THE MEDICAL EXAMINER'S 2021 BUDGET TO APPROPRIATE ADDITIONAL OPERATING EXPENSES AND INCREASE FINES AND LICENSES REVENUE

WHEREAS the Waukesha County Medical Examiner's Office issues cremation permits, which are required before a cremation can take place pursuant § 979.10, Wisconsin Statutes; and

WHEREAS based on year-to-date and revenue projections for cremation permits, the Medical Examiner's Office anticipates exceeding the 2021 budget by \$52,000; and

WHEREAS the Waukesha County's Medical Examiner's Office is experiencing a significant increase in examination cases; and

WHEREAS the Medical Examiner's Office has incurred additional operating expenses, including additional costs for medical testing services and livery services for examination cases; and

WHEREAS the additional expenses cannot be accommodated within the existing 2021 operating budget, and

WHEREAS the Medical Examiner's Office is requesting \$52,000 of additional expenditure authority to pay for the above-budget operating expenses, which will be funded with above-budget cremation permit revenue.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Medical Examiner's Office 2021 budget be modified by increasing fines and license revenue by \$52,000 and increase operating expense appropriations by \$52,000.
