## ACCEPT DONATED FITNESS EQUIPMENT FOR THE SHERIFF'S DEPARTMENT WORKOUT ROOM

WHEREAS, Wisconsin Athletic Club expressed an interest in donating used fitness equipment for the Sheriff's Department workout room; and

WHEREAS, the fitness equipment will not be included in a replacement plan or replacement will not be levy funded.
