

ENROLLED ORDINANCE 177-104

APPROVE MEDICARE SET-ASIDE AGREEMENT FOR WORKER'S COMPENSATION
CASE ENTITLED GERALYN PAGENKOPF VS. COUNTY OF WAUKESHA

WHEREAS, a former employee of the Waukesha County Department of Emergency Preparedness has filed a Worker's Compensation claim against Waukesha County for injuries allegedly occurring while employed with Waukesha County; and

WHEREAS, in September 2022, the County Board passed Enrolled Ordinance 177-57 which approved a limited compromise agreement with the employee. The compromise agreement was limited because the Centers for Medicare & Medicaid Services ("CMS") had yet to approve the required Medicare Set-Aside Agreement which would allow a full and final Worker's Compensation settlement to be approved; and

WHEREAS, CMS has now approved the Medicare Set-Aside Agreement, and the parties now wish to finally and completely resolve this matter.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Medicare Set-Aside Agreement on file with the Corporation Counsel and previously shared with the Board in the Worker's Compensation case entitled Geralyn Pagenkopf vs. County of Waukesha is hereby approved.

BE IT FURTHER ORDAINED that Corporation Counsel or his designee is authorized to take all actions necessary to have the previously approved Limited Compromise Agreement converted to a Full and Final Settlement Agreement.
