

ENROLLED ORDINANCE 177-12

AMEND ARTICLE V, DIVISION 1 OF CHAPTER 4 OF THE WAUKESHA
COUNTY CODE OF ORDINANCES – GENERAL INFORMATION

WHEREAS, in 2022 the County Board will review the County's operating budget through joint meetings of the standing committee and finance committee; and

WHEREAS, the Waukesha County Code of Ordinances needs to be changed to allow the joint budget review meetings to be chaired by the finance committee chair.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that Section 4-97(d) of the Waukesha County Code of Ordinances is repealed and recreated to read:

(d) The county board chairperson shall arrange for joint committee meetings when such a meeting is deemed necessary, and shall set the time and location of the meeting. The county board chairperson, or in the chairperson's absence the first vice chairperson, or in the first vice chairperson's absence the second vice chairperson, shall preside except that the finance committee chairperson shall preside over any joint committee meeting when reviewing the budget, or the standing committee chairperson in finance committee chairperson's absence.

1. No business shall be conducted at a joint meeting unless there is a quorum from each committee present. Committee members present and serving as members of more than one (1) of the committees meeting jointly are to be considered present in determining whether there is a quorum of each committee.
2. Committee members serving on more than one (1) of the committees meeting jointly shall be entitled to cast separate votes as a member of each committee on which the member serves.


