MODIFY THE DEPARTMENT OF HEALTH AND HUMAN SERVICES 2025 BUDGET TO ACCEPT THE WISCONSIN DEPARTMENT OF HEALTH SERVICES ROOM AND BOARD SERVICES ASSOCIATED WITH RESIDENTIAL SUBSTANCE USE DISORDER OPIOID TREATMENT GRANT AND APPROPRIATE ADDITIONAL EXPENDITURES

WHEREAS, the Wisconsin Department of Health Services (DHS) has awarded the Waukesha County Department of Health and Human Services (WCDHHS) a Room and Board Services Associated with Residential Substance Use Disorder Opioid Treatment Grant (R&B RUSD) of \$59,521 to be used between January 1, 2025 and December 31, 2025; and

WHEREAS, WCDHHS currently provides financial assistance through payment plans to eligible Medicaid beneficiaries seeking residential substance use treatment, enabling them to utilize their Medicaid benefits for treatment services and provide support for room and board which Medicaid does not cover; and

WHEREAS, the demand for financial assistance for this service has outpaced what WCDHHS has been able to allocate; and

WHEREAS, WCDHHS will utilize the R&B RUSD grant funding to compensate contracted residential providers with a negotiated daily room and board rate for each day of residential substance use treatment services provided to a resident under the Medicaid residential substance use disorder benefit; and

WHEREAS, available revenues were not anticipated nor included in the 2025 budget; and

WHEREAS, WCDHHS is proposing to amend the 2025 adopted budget by increasing general government revenue by \$59,521 and increasing operating expenses by \$59,521.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Department of Health and Human Services is authorized to accept the Wisconsin Department of Health Services Room and Board Services Associated with Residential Substance Use Disorder Opioid Treatment grant of \$59,521.

BE IT FURTHER ORDAINED that the 2025 Waukesha County Department of Health and Human Services budget be modified to increase general government revenue by \$59,521, and operating expenses by \$59,521 to provide funding for room and board costs for individuals with Medicaid who need residential substance use disorder treatment programs due to an opioid use disorder.

MODIFY THE DEPARTMENT OF HEALTH AND HUMAN SERVICES 2025 BUDGET TO ACCEPT THE WISCONSIN DEPARTMENT OF HEALTH SERVICES ROOM AND BOARD SERVICES ASSOCIATED WITH RESIDENTIAL SUBSTANCE USE DISORDER OPIOID TREATMENT GRANT AND APPROPRIATE ADDITIONAL EXPENDITURES

This ordinance modifies the 2025 Department of Health and Human Services (HHS) budget to accept \$59,521 in opioid treatment grant funding from the Wisconsin Department of Health Services for room and board services associated with residential substance use disorder treatment. These funds will be used to reimburse contracted residential treatment providers at a negotiated daily rate for eligible Medicaid beneficiaries.

The ordinance increases both general government revenue and operating expenditures by \$59,521. The grant funding will be utilized between January 1, 2025, and December 31, 2025, to support individuals in need of residential treatment services that Medicaid does not fully cover.
