ESTABLISH PARKS AND LAND USE CAPITAL PROJECT RESERVE FUND

WHEREAS, the Department of Parks and Land Use administers some capital projects that are partly funded with state and federal revenues, and

WHEREAS, the Wisconsin Department of Transportation provides oversight for design and construction review of these projects, for which the County is charged, and

WHEREAS, these projects are subject to federal audit and could result in final payments years after the County closes out projects in accordance with County policies, and

WHEREAS, these delayed payment requests must be provided for, and

WHEREAS, since 1991 the County has used a policy to resolve similar delayed payment issues

for federally funded highway capital projects, by receiving Finance Committee approval each year to set aside a portion of project fund balances into a reserve fund to cover future-year payments, and

WHEREAS, it is anticipated that a reserve fund for Parks and Land Use capital projects would first be needed for year-end 2017 for the expected closure of the Bikeway Pavement Improvement capital project (#200014).

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that, upon recommendation of the Departments of Parks and Land Use and Administration, and upon approval of the Finance Committee, a portion of capital project fund balance remaining will be reserved upon completion of projects that are funded in part with federal or state aid, and the total amount in the Parks & Land Use Capital Project reserve fund is not to exceed \$50,000.
