## REFERENDA

#### STATE REFERENDUM

"Eligibility to vote. Shall section 1 of article III of the constitution, which deals with suffrage, be amended to provide that only a United States citizen age 18 or older who resides in an election district may vote in an election for national, state, or local office or at a statewide or local referendum?"

## SCHOOL DISTRICT REFERENDA

## ARROWHEAD UNION HIGH SCHOOL DISTRICT

Question Number I: Shall the Arrowhead Union High School District, Waukesha County, Wisconsin be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,900,000 per year for four years, beginning with the 2025-2026 school year and ending with the 2028-2029 school year, for non-recurring purposes consisting of educational, operational, and maintenance expenses?

Question Number II: Shall the Arrowhead Union High School District, Waukesha County, Wisconsin be authorized to issue pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$261,200,000 for the public purpose of paying the cost of a school building and facility improvement project consisting of: construction of a new high school building, including an auditorium and pool, to consolidate grades 9-12 into one building on the current campus to improve safety, security, efficiency, and learning spaces; related demolition of current facilities; athletic facility and site improvements; and acquisition of furnishings, fixtures, and equipment?

## EAST TROY COMMUNITY SCHOOL DISTRICT

Question: Shall the East Troy Community School District, Walworth and Waukesha Counties, Wisconsin be authorized to issue pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$19,400,000 for the public purpose of paying the cost of a school facility improvement project consisting of: capital maintenance, safety, security, renovations, building infrastructure and site improvements at the High School, Middle School and Prairie View Elementary School; improvements to the bus garage and site; and acquisition of furnishings, fixtures and equipment?

## MUKWONAGO AREA SCHOOL DISTRICT

Question: Shall the Mukwonago Area School District, Waukesha and Walworth Counties, Wisconsin be authorized to issue pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$89,100,000 for the public purpose of paying the cost of a school building and facility improvement project consisting of: construction of an addition and renovations to the Park View Middle School building and demolition of a portion of the existing building; district-wide capital maintenance, infrastructure and site improvements; and acquisition of furnishings, fixtures and equipment?

## SCHOOL DISTRICT OF WEST ALLIS-WEST MILWAUKEE

Question Number I: Shall the School District of West Allis-West Milwaukee Milwaukee and Waukesha Counties, Wisconsin be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$5,800,000 beginning with the 2025-2026 school year, for recurring purposes consisting of only teacher and staff compensation?

Question Number II: Shall the School District of West Allis-West Milwaukee Milwaukee and Waukesha Counties, Wisconsin be authorized to issue pursuant to Chapter 67 of the Wisconsin Statutes, general obligation bonds in an amount not to exceed \$70,000,000 for the public purpose of paying the cost of a district-wide school facility improvement project consisting of: safety, security and accessibility updates;

roofing, HVAC, boiler, technical education, building infrastructure and site repairs; capital maintenance; and acquisition of furnishings, fixtures and equipment?

## MUNICIPAL REFERENDA

## **VILLAGE OF ELM GROVE**

Shall the Village of Elm Grove complete the Stormwater Management Plan developed in response to severe flooding by daylighting and realigning Underwood Creek south of Watertown Plank Road through the downtown area? The existing creek enclosure located under the Park and Shop parking lot and the Sendik's building is failing, and will not receive permitting for significant repair from the Wisconsin Department of Natural Resources or the U.S. Army Corps of Engineers. The Village will acquire land and easements and construct a naturalized streambed for the purpose of Village stormwater management. This project will protect public safety, create public space, connect pedestrian pathways and enhance the economic viability of the downtown. The project will be paid for with funding from Tax Incremental Financing District #2, existing storm water fees, and grants. The total project cost SHALL NOT exceed \$8,500,000.

## VILLAGE OF LANNON

"Under state law, the increase in the levy of the Village of Lannon for the tax to be imposed for the next fiscal year, 2025, is limited to 13.680%, which results in a levy of \$752,545. Shall the Village of Lannon be allowed to exceed this limit and increase the levy for the next fiscal year, 2025, for the purpose of providing funding for increased police services, and fire and emergency medical services provided by the Village of Menomonee Falls, by a total of 16.610%, which results in a levy of \$877,545, and on an ongoing basis, include the increase of \$125,000 for each fiscal year going forward?"
