The property is described as part of the W ½ of the NW ¼ of Section 36, T7N, R18E, Town of Delafield. More specifically, the property is located at W288 S250 Elmhurst Road and contains approximately 2.2 acres.

TOWN PLAN COMMISSION AND BOARD ACTION:

On May 7, 2024, the Town of Delafield Plan Commission recommended unanimous approval of the rezone. On May 14, 2024, the Town of Delafield Board recommended unanimous approval of the rezone.

COMPLIANCE WITH THE COMPREHENSIVE DEVELOPMENT PLAN (CDP) FOR WAUKESHA COUNTY AND THE TOWN OF DELAFIELD CDP:

The lands are designated in the Rural Density and Other Agricultural Lands (one dwelling unit per five acres) category. The parcel contains one dwelling unit that existed prior to its designation in this category. The plans recommend zoning lands as used. Therefore, because the zoning change does not create additional density, the proposal conforms to plan recommendations.

STAFF ANALYSIS:

The subject 2.2-acre parcel has frontage on Elmhurst Road. The parcel is fairly long and narrow and contains a wetland in the middle part of the property with wooded areas to the east. The petitioners have recently razed a non-conforming garage that sat near the road and the existing home remains. The existing A-1 zoning designation has a 40-acre minimum lot size. The A-3 district minimum lot area is two acres. The A-3 district requires 85% open space, whereas the A-1 requires 95% open space. The amended Referred on: 07/01/24

category will enable the petitioner to construct an outbuilding in a conforming location without violating the open space standards of the proposed zoning designation.

STAFF RECOMMENDATION:

It is the opinion of the Planning and Zoning Division Staff that this request be <u>approved</u>. The proposed rezoning places the subject parcel to a more appropriate category and will allow for a reasonable amount of impervious surface on the lot enabling the owners to further improve the lands.

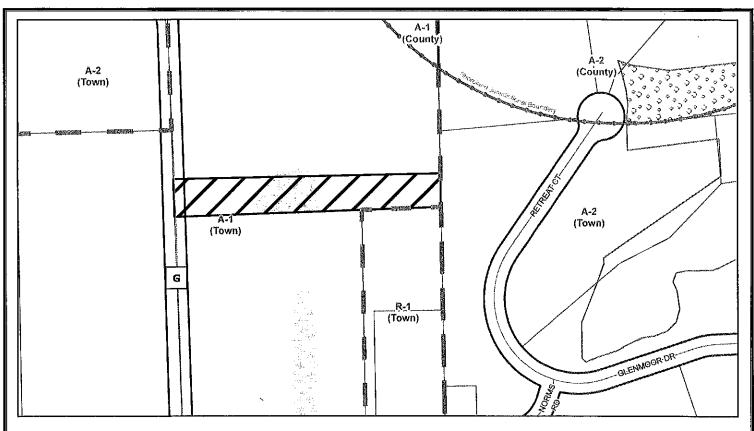

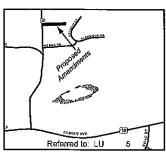

AN ORDINANCE TO AMEND THE ZONING MAP OF THE TOWN OF DELAFIELD FROM A-1 TO A-3 ON LANDS LOCATED AT W288S250 ELMHURST ROAD, TAX KEY DELT 0862-997, TOWN OF DELAFIELD, WAUKESHA COUNTY WISCONSIN

The Town Board of Delafield, Waukesha County, Wisconsin, does hereby ordain as follows:

SECTION 1: The Town of Delafield Zoning Map is hereby amended to change the zoning classification from A-1 to A-3 on the following described parcel of land:

Part of the West ½ of the Northwest ¼ of Section 36, T7N R18E, commencing at the Northwest corner of said section, thence running East on the North line of said Section 1344.96 feet to the West 1/8 line of said Section; then South on West 1/8 line 605.41 feet to the point of beginning; then continuing South on West 1/8 line 104.00 feet; then South 87°32′22″ West 845.78 feet to the centerline of Highway "G', thence North 1°53′44″ West, along said centerline 125.30 feet; thence South 88°47′09″ West, 847.51 feet to the West 1/8 line and the point of beginning.

SECTION 2: Severability.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 3: Effective Date.

This ordinance shall take effect immediately upon passage by Waukesha County and posting or publication as provided by law.
