WHEREAS, the County owns and operates a system of county trunk highways (CTH); and

WHEREAS, the County undertakes projects for improvement of traffic safety, level of service, and bridge sufficiency conditions at various locations when conditions warrant; and

WHEREAS, the CTH CW Bridge at Ashippun River capital project #200810 to replace steel girder along the bridge and to reconstruct and realign 2,100 feet of approach roadway for safety was included in the capital plan from 2008 through 2015; and

WHEREAS, in 2018 the County believed that billing for this project from the Wisconsin Department of Transportation (WisDOT) was substantially complete, with a positive balance of \$114,726; and

WHEREAS, the County maintains a Highway Capital Project Reserve Fund, comprised of a portion of lapsed project dollars, to accommodate WisDOT invoices received after the County closes projects; and

WHEREAS, upon review of closed projects, it has been determined there are outstanding WisDOT invoices for capital project #200810 totaling \$89,872; and

WHEREAS, this reserve fund does not have sufficient funds to cover this large invoice and other post-closure invoices, and Capital Project Fund balance is needed to fund this remaining invoice.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the 2024 Capital Project budget be modified to appropriate additional expenditures of \$89,872 and increase use of Capital Project Fund balance by \$89,872 for capital project #200810 CTH CW at Ashippun River Bridge.

FISCAL NOTE

MODIFY THE 2024 CAPITAL PROJECT BUDGET TO INCREASE EXPENDITURES FOR CAPITAL PROJECT #200810, CTH CW AT ASHIPPUN RIVER BRIDGE

This ordinance modifies the 2024 Capital Projects budget to increase expenditures by \$89,872 for project #200810 CTH CW at Ashippun River Bridge. The county maintains a Highway Capital Project Reserve Fund (separate from the Capital Project Fund) to cover invoices received after projects have closed (e.g., from state/federal audits). The Finance Committee considers and approves requests to transfer a portion of remaining project balances to fund this reserve. Normally, these post-closure invoices are relatively small, and the reserve fund can accommodate these bills, but this invoice, along with another being addressed in a similar ordinance, would exceed the \$93,766 balance currently in the fund. This ordinance would approve the use of \$89,872 of Capital Project Fund balance to cover this invoice.
