

ENROLLED ORDINANCE 177-89

MODIFY SPEED ZONE ON COUNTY TRUNK HIGHWAY KF
FROM LINDSAY ROAD TO CTH JK

WHEREAS, Wisconsin Statutes §349.11 permits local authorities to modify speed restrictions within statutory guidelines; and

WHEREAS, in response to public inquiries and a review of vehicle speeds and collisions along this segment of highway, the Waukesha County Department of Public Works finds it appropriate, pursuant to Wisconsin Statutes §346.57(4)(g), to modify the speed limit to 45 mph in both directions of County Trunk Highway KF from a point three hundred and fifty (350) feet north of the centerline of Lindsay Road to its intersection with CTH JK in the City of Pewaukee and the Town of Lisbon.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that that the speed zone along both directions of County Trunk Highway KF in the City of Pewaukee and the Town of Lisbon is modified to be forty-five (45) miles per hour from a point three hundred and fifty (350) feet north of the centerline of Lindsay Road to its intersection with CTH JK.

BE IT FURTHER ORDAINED that this ordinance rescinds all previous speed restrictions for the above-described portion of the County Trunk Highway System.





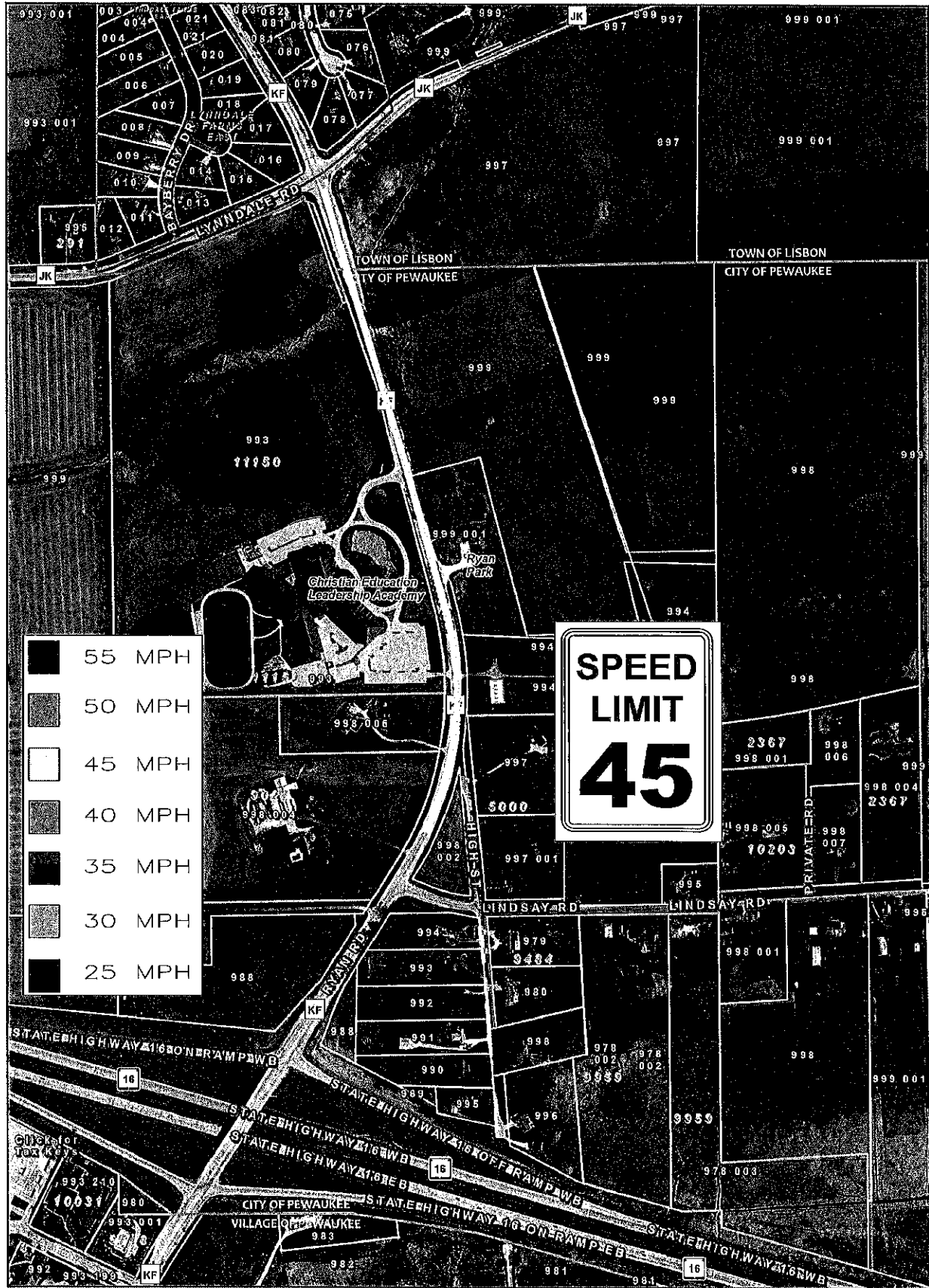
