REPURPOSE OF URBAN AREA SECURITY INITIATIVE GRANT FUNDS

WHEREAS, the United States Department of Homeland Security designated Waukesha County, along with the City of Milwaukee, Milwaukee, Ozaukee, Racine and Washington Counties as an Urban Area eligible for grant funding to enhance the capabilities to prevent, respond to, and recover from acts of terrorism and other all hazard events, and

WHEREAS, the State of Wisconsin issued a grant award to Waukesha County to purchase and install an emergency generator, and

WHEREAS, the anticipated grant revenues and expenditure authority exist in the Emergency Preparedness Department-Emergency Management budget for 2013, and

WHEREAS, the original project was subsequently determined to be infeasible, and

WHEREAS, Waukesha County Facilities and Parks and Land Use Department recommended repurposing those funds to provide emergency power transfer equipment for the Waukesha County Expo Forum building, which is designated as a County Business Continuity site and as an emergency shelter facility in times of disaster, but does not currently have emergency power capacity, and

WHEREAS, the Wisconsin Office of Justice Assistance indicated their concurrence with the repurpose and will issue a revised grant award.

THE COUNTY BOARD OF SUPERVISORS OF WAUKESHA COUNTY ORDAINS that the Waukesha County Emergency Preparedness Department-Emergency Management Office is authorized to repurpose existing Federal Homeland Security grant funds to purchase and install emergency power transfer equipment at the Waukesha County Expo Forum building.
