7TH AMENDMENT TO LEASE AGREEMENT WITH VERIZON WIRELESS  
PERSONAL COMMUNICATIONS LP, D/B/A VERIZON WIRELESS

WHEREAS, Waukesha County owns a tower (the "Tower") located at the N46 W33480 C.T.H.R., Nashotah, Waukesha County, State of Wisconsin (the "Site"); and

WHEREAS, Verizon Wireless Personal Communications LP, d/b/a Verizon Wireless, ("Verizon") currently leases space on the Tower and at the Site for operation of a cellular communications facility and subleases space to AT&T Mobility Corporation ("AT&T") pursuant to a Lease Agreement dated February 14, 1997, as amended; and

WHEREAS, Verizon and AT&T desire to replace, modify or relocate various equipment, antennas and/or feedlines on the Tower in order to update aged equipment; and

WHEREAS, the County is willing to permit the upgrades, and otherwise amend the Lease with Verizon without requiring an increase in rent.


