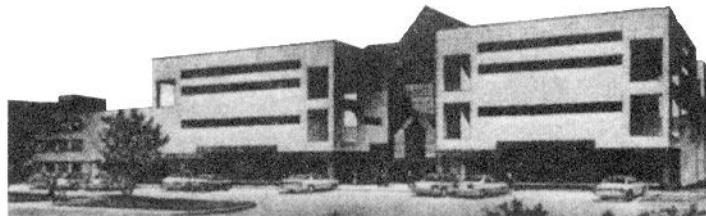

**Sex Offender Information Bulletin**

**Date: November 30, 2022**

The Waukesha County Sheriff's Department, in cooperation with the Sex Offender Registration Committee, is releasing the following information pursuant to Wisconsin State Statutes 301.46(2m) which authorizes law enforcement agencies to inform the public of a sex offender's release when, at the discretion of the agency, the release of information will enhance public safety, awareness and protection.

**This sex offender has served the prison sentence imposed on him by the courts.** The individual who appears on this notification has been convicted of a sex offense. Further, his criminal history places him in a classification level which reflects the *potential to* reoffend.

The offender, under the supervision of the Department of Corrections, Division of Community Corrections, will be living in the location listed below. **He is not wanted by the police at this time. This notification is not intended to increase fear; rather, it is our belief that an informed public is a safer public.**

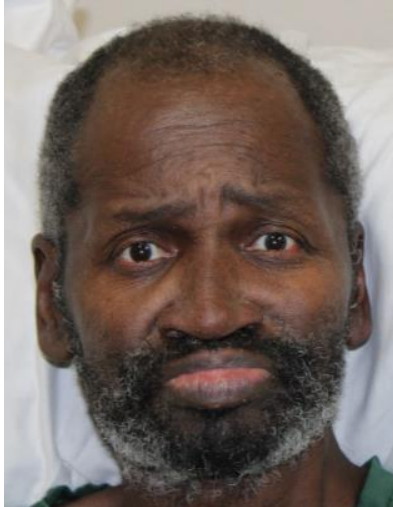

Sex offenders **have always** lived in our communities, but it wasn't until Act 440 (June 1997) that law enforcement is now able to share this information with the community. Citizen abuse of this information to threaten, intimidate or harass registered sex offenders will not be tolerated. Please understand that such abuse could potentially end law enforcement's ability to do community notifications. We believe **the only person who wins if community notification ends is the sex offender**, since sex offenders derive their power through secrecy.

- 1986 – Attempted Enticement of a Child for Immoral Purposes: 944.12 & 939.32

Isaac will be released in December of 2022. He will be a LIFE REGISTRANT with the Sex Offender Registry. He is to comply with Supervised Release Rules and will be on LIFETIME G.P.S. monitoring.
