ACCEPT STATE OF WISCONSIN TELEPHONIC-ASSISTED CARDIOPULMONARY RESUSCITATION PROGRAM FUNDING AND MODIFY THE EMERGENCY PREPAREDNESS 2019 BUDGET TO APPROPRIATE GRANT REVENUES AND EXPENDITURES

WHEREAS, the Communications Division of the Waukesha County Emergency Preparedness Department currently maintains a center that supports telephonic-assisted cardiopulmonary resuscitation (T-CPR) in Waukesha County; and

WHEREAS, the Communications Division of the Waukesha County Emergency Preparedness Department requires its staff to maintain its Emergency Medical Dispatch certification through ongoing training; and

WHEREAS, the Communications Division of the Waukesha County Emergency Preparedness Department provides updated equipment, allowing staff to effectively provide T-CPR instructions; and

WHEREAS, Wisconsin Division of Public Health has awarded \$15,586 in grant funding to Waukesha County to assist with funding the equipment and training necessary to provide T-CPR to the citizens of Waukesha County.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Emergency Preparedness Department is authorized to accept \$15,586 in grant funding from Wisconsin Division of Public Health to assist in funding the equipment and training necessary to provide T-CPR instruction.

BE IT FURTHER ORDAINED that the Emergency Preparedness 2019 budget be modified by appropriating operating expenses of \$11,372 to fund replacement headsets and training manikins, personnel expenses of \$4,214 to fund overtime training costs to provide T-CPR instruction, and increasing intergovernmental revenues by \$15,586 for corresponding State of Wisconsin grant revenues.

This ordinance authorizes the appropriation of \$15,586 of Wisconsin Department of Health Services-Division of Public Health telephonic-assisted cardiopulmonary resuscitation (T-CPR) grant awards in the Waukesha County Department of Emergency Preparedness' 2019 budget. The funding will be used to cover \$11,372 in equipment costs related to 30 new communication headsets and 12 training manikins, and \$4,214 to cover overtime costs for telecommunicators associated with staff training opportunities.

The use of grant funding for the additional expenditures results in no impact to the 2019 tax levy.
