# MODIFY THE 2023 WORKFORCE AND ECONOMIC DEVELOPMENT FUND BUDGET TO ACCEPT WINNING WITH WISCONSIN'S WORKFORCE EVENT SERIES GRANT AND APPROPRIATE EXPENDITURES

WHEREAS, the Wisconsin Department of Workforce Development has created a Winning with Wisconsin's Workforce Event Series Grant; and

WHEREAS, the Winning with Wisconsin's Workforce Event Series Grant creates quarterly opportunities for regional Workforce Development Boards and supporting stakeholders to highlight available workforce resources and feature businesses for their recruitment and retention strategies; and

WHEREAS, Waukesha County, as the fiscal agent for the Waukesha, Ozaukee, Washington Workforce Development Board, is an eligible grantee; and

WHEREAS, the grant funds of \$20,000 available to Waukesha County provide an opportunity for the Waukesha, Ozaukee, Washington Workforce Development Board and its business solutions group team to promote available workforce services for job seekers and businesses; and

WHEREAS, the Waukesha, Ozaukee, Washington Workforce Development Board will utilize the grant funding to host events in 2023 that will bring together business leaders and representatives from the workforce system; and

WHEREAS, the grant provided will fund both \$18,000 in direct operating expenses requiring budget modification and \$2,000 in administrative cost recovery, such as staff time, which is already included in the 2023 budget and does not require budget modification.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Department of Parks and Land Use is authorized to accept the Winning with Wisconsin's Workforce Event Series Grant.

BE IT FURTHER ORDAINED that the 2023 Parks and Land Use — Workforce and Economic Development Fund Budget be modified by appropriating operating expenditures of \$18,000 and increasing general government revenue by \$18,000.

# MODIFY THE 2023 WORKFORCE AND ECONOMIC DEVELOPMENT FUND BUDGET TO ACCEPT WINNING WITH WISCONSIN'S WORKFORCE EVENT SERIES GRANT AND APPROPRIATE EXPENDITURES

This ordinance authorizes the Department of Parks and Land Use – Workforce and Economic Development Fund to accept \$20,000 of Wisconsin Department of Workforce Development grant funding under the Winning with Wisconsin's Workforce Event Series. This grant is intended to convene four events with local and regional business leaders to learn, access, and engage with workforce development resources. Each event will focus on a different topic, including workforce participation, technology and training, and removing barriers to employment. This ordinance appropriates \$18,000 in operating expenses to carry out these events. The remaining \$2,000 is expected to fund administrative costs related to the grant, such as staff time, which is already included in the 2023 budget and does not require further budget modification.

This ordinance has no direct impact on county tax levy.
