WHEREAS, the State of Wisconsin, Department of Health Services has made available Crisis Quality Improvement Rapid Cycle funds of \$20,000 in 2019 to the Waukesha County Department of Health and Human Services; and

WHEREAS, available revenues were not anticipated nor included in the 2019 budget; and

WHEREAS, the Rapid Cycle funding seeks to provide meaningful change by developing and expanding crisis services through evidence based practices and strategies; and

WHEREAS, the Department of Health and Human Services will utilize funding to provide training for Question, Persuade, Refer (QPR) Train the trainer and training on the Collaborative Assessment and Management of Suicide (CAMS-Care).

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Department of Health and Human Services, Division of Clinical Services, 2019 Budget be modified by appropriating \$20,000 of operating expenses and increasing General Government Revenues by \$20,000 for approved Crisis Quality Improvement Rapid Cycle revenue.
