

ENROLLED ORDINANCE 179-65

ESTABLISH AND APPROVE THE DEPARTMENT OF HEALTH AND HUMAN SERVICES  
2025 FEES FOR COMMUNITY MENTAL HEALTH, DEVELOPMENTAL DISABILITIES,  
AND SUBSTANCE USE DISORDER SERVICES

WHEREAS, the Waukesha County Department of Health & Human Services (HHS) provides billable services to clients for community mental health, developmental disabilities, and substance use disorders under §51.42 Wisconsin Statutes; and

WHEREAS, DHS 1.03(2), Wisconsin Administrative Code, requires the Waukesha County Board to annually establish and approve the usual and customary fee schedule for community mental health, developmental disabilities, and substance use disorders; and

WHEREAS, the establishment of these fees is required by third-party payors and helps approximate the cost of providing the services; and

WHEREAS, HHS contracts with various insurance providers and charges a lower, contracted rate, similar to Medicare approved rates, for services provided to a client with a contracted insurance provider; and

WHEREAS, the usual and customary fee schedule for 2025 will remain constant to the 2024 schedule; and


WHEREAS, the 2025 HHS budget contemplated the 2025 usual and customary fee schedule and contracted rates and no budget modification is necessary.


THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the usual and customary fee schedule, unless otherwise specified by contract, for community mental health, developmental disabilities, and substance use disorders, as indicated in Table 1 on file with the Department of Health & Human Services and made part of this ordinance by reference, be approved.





Mental Health Outpatient Services includes Clinic services, Crisis Services, Comprehensive Community Services (CCS), Community Support Program (CSP), and Targeted Case Management (TCM).

The amounts billed for services may be different from the prices listed here based on standard medical billing procedures and practices (e.g., 15-minute increments, hourly increments, fixed fees), add-on services, and limitations on length of appointment. Fees for standard medical billing procedures are based on the above rates.

All of the above services (except Juvenile Detention Services and Family and Adolescent services) are billed to all third-party payers, including Medicare and Medicaid, before being billed to the client or his/her responsible party. All Medicaid and Medicare deductibles and copayments are the client's responsibility. Upon complying with DHS 1.05(4) regulations and the provision of all necessary financial information, the client's liability for charges may be reduced or limited to a monthly minimum payment.

Clients provided services in the Huber Jail Facility will be informed regarding fees upon entering the program.
