Authorize the Waukesha County Department of Health and Human Services to Accept the Radiation Monitoring Equipment Donation from Pierce County

WHEREAS, one of the foundational capabilities of the Waukesha County Department of Health and Human Services, Public Health Division, is emergency preparedness and response to ensure Waukesha County can effectively respond to public health emergencies; and

WHEREAS, Health and Human Services - Public Health, is tasked with operating Community Reception Centers in the event of a radiological emergency; and

WHEREAS, portable radiation monitors are a major component of Community Reception Centers to do contamination screening for detection of radiological material; and

WHEREAS, Pierce County Emergency Management has recently upgraded their radiation monitors and are willing to donate their four older models to Waukesha County; and

WHEREAS, the value of the portable radiation monitors are \$8,500 per machine for a total equipment donation of \$34,000; and

WHEREAS, the only required cost for this equipment is one-time exempt radiation test source maintenance that will cost approximately \$250 and can be covered within the current operating budget.

THE COUNTY BOARD OF SUPERVISORS OF THE COUNTY OF WAUKESHA ORDAINS that the Waukesha County Department of Health and Human Services is authorized to accept the radiation monitoring equipment donation valued at \$34,000 from Pierce County.
